### How do you leave a bequest?

A bequest -- making a gift -- can be done by including a simple clause in your will. You can leave:

- a specific amount
- a number of securities; or
- the whole or a portion of the remainder of your estate to the church.

You may direct your gift to a specific area of church activity by contributing to one of three special funds, or have the Fairlawn Executive Council direct your gift to the area of greatest need. If you do not specify which fund is to receive the gift, the first \$5,000 of your gift will be dealt with as part of the general funds of the church and the balance will be added to the Fairlawn Legacy Fund.

### What funds may you specify?

The church funds reflect our three purposes – Explore Spirituality, Experience Belonging, Embrace Action.

<u>Christian Education Fund</u> – a fund from which income and/or capital contributes to the enrichment of our Christian experience at Fairlawn, including worship, music, adult and children's education, professional development for ministers and other activities related to helping us 'Explore Spirituality.'

<u>Fairlawn Legacy Fund</u> – a fund from which income and/or capital is used, at the discretion of

Fairlawn's Executive Council, for costs related to pastoral care and the ways we care for one another, and to the operations of Fairlawn, including major initiatives and capital expenses that enable all who attend Fairlawn to 'Experience Belonging.'

<u>Social Justice Fund</u> – a fund whose use is guided by the vision of Fairlawn being an inspiring and thriving champion of social justice where the congregation is passionately engaged in actions which transform society, individual lives and ourselves. It works toward the creation of a just and sustainable world. This fund helps manifest our church's commitment to 'Embrace Action.'

The disbursement of this Fund's income and/or capital is approved by Executive Council, informed by established criteria available to read on our website, and approved by Executive Council.

### How long may your legacy last?

Your gift can last for as long as you like. Should you wish that only the investment income from your gift be used, and that the principal always remains unspent, you may specify that in your will. In that way, your gift keeps giving always. For example, a \$10,000 bequest producing a 4% annual return would provide \$400 of assistance to the church each year in perpetuity. Alternatively, a gift from which income and/or principal can be drawn on for major church initiatives will enable Fairlawn to achieve more substantial change over a shorter period.
